## Invitation for Scholarship Applications

### AMCA Toronto Scholarship 2014

AMCA – Toronto, in accordance with its status and purpose within the Croatian community in the Greater Toronto Area (GTA), and according to its Statute, is announcing an invitation for 2014 Student Scholarship applications.

The purpose of the AMCA Student Scholarship is to provide financial assistance to a Canadian or Croatian university student and to promote the AMCA name and mandate within the Croatian community in the GTA.

There will be two \$1,000 scholarships awarded.

Scholarship applications are to be submitted to AMCA's mailing address (see above) or via e-mail to AMCA's electronic address, [scholarship@AMCAtoronto.com](mailto:scholarship@AMCAtoronto.com), in .pdf format, no later than May 15, 2014.

Each candidate must apply, in writing, with one (1) application which must include the applicant's full name, complete contact information, full address, academic details and a brief, original request for the scholarship. The official *Transcript of Consolidated Academic Record* must be submitted with the application. The required brief, original request must include an explanation of the purpose for which the scholarship will be used. It is recommended that the request be written in the Croatian language, and it should be no longer than 250 words.

By submitting an application, each candidate agrees and confirms that he/she:

- Fully accepts all AMCA Scholarship Committee rules and conditions, and further accepts the Committee's decisions as final and binding;
- Forfeits the right to dispute and/or complain against the decisions made by the AMCA Scholarship Committee;
- Has the legal obligation to accept the scholarship when it is awarded, including signing the award receipt;
- Agrees that the Sponsor may, without limitation or further compensation or notice, use his/her name, voice and/or likeness in any and all media, worldwide, for the purpose of advertising and promoting the AMCA Scholarship Award;
- Guarantees to have filed the application by his/her own free will, by him/herself, and that the application contains correct, truthful and legally valid information;
- Guarantees that the application contains NO obscene, pornographic, libellous or otherwise objectionable items;
- Agrees to indemnify and hold harmless AMCA and its board members from and against any and all third party claims, actions or proceedings of any kind and from any and all damages, liabilities, costs and/or expenses arising out of any breach or alleged breach of any warranties, representations or agreements made by the Applicant hereunder, and;
- Agrees, in the event that the scholarship is awarded to her/him, to attend the annual AMCA Fundraising Gala Dinner in Toronto to accept the award and to be introduced to the membership (attendance is free of charge, date and time to be confirmed).
